The member of the public updated members on an internet service which is based on the Keele University Campus. They operate the Mow Cop transmitter. Their details are Internet Central Limited, Innovation Centre, Keele Science Park. Internet Central is a subsidiary of Goodwin plc, an engineering group based in Stoke-on-Trent. He also wished the members to recall the Neighbourhood Plan and the demand for improved broadband in the Parish. There had been some improvements, but they were only minor.

Resolved to suspend the Standing Orders to accept a report from the Ward Councillor L Wardlow.

Cheshire East Council was going to have the ability to bid for a portion of the £200m available to improving broadband in rural areas especially if there was a school. Remembrance Sunday had been an amazing success across the borough, the beacon on Mow Cop had attracted a huge audience.

CE had adopted an International Tolerance Policy which included anti-Semitism.

The Clerk had subsequently contacted Mr S Wallace, CE highways and requested a meeting, he had agreed providing the Parish Council summarised their concerns. The focus was to install a Speed Display Unit on the A34 and to move the existing one further away from the Village Green on the south side.

There had been two accidents in the village one on the 01.11.18 and the other on 09.11.18, both were noted.

Signs in the Parish

There were several signs damaged in the Parish and needed attention. The members took some areas of responsibility and agreed to report back to the Clerk by the end of the month.

149/18 Community Home Bonus

The presentation had been of little benefit from Connecting Communities. The Ward Cllr was asked by the Chairman to investigate the reasons behind the poor response.

The Clerk was requested to make enquires if it was possible to utilise external funding to improve the broadband service in the area and if it would fit the criteria in the application form. If there was a chance the funding would assist, the Clerk was requested to continue with the bid.

They wished to extend the quarrying to 2023/24 and this would subsequently extend the restoration to 2024/25.
