Public Forum

2 members of the public present (to be noted their children were also present). Both residents lived on Wallhill Lane and had attended the meeting to gain the support of the Parish Council to close Wallhill Lane as this would result in the most ideal option to mitigate road safety when the CLR was opened in 2020. The situation was unsafe now without the predicted increase in traffic after opening of the CLR with vehicles travelling to the A34. Both residents gave examples of 'near misses' and accidents that had occurred. The residents explained they understood from verbal sources Mr Sean Halewood CEC Highways Officer (leading the project) had expressed support for closure. Cameras and speed bumps were

inappropriate.

Two children also gave a resume of how unsafe the speed and volume of traffic was from the viewpoint of a child living on the lane.

The Chairman wished it to be noted that after the various email exchanges and the contact from the local press, the Parish Council had made no decision on the mitigation measures for Wallhill Lane at this time. The PC were awaiting contact from the CE Highway officers.

80/19 CCTV

The Clerk had circulated the relevant documents from ICO. JDH Services Ltd had offered free guidance as the PC had instructed the company for advice in 2018.

Cllr N Plant proposed 'the option of CCTV was not pursued on the Village Green. 'Cllr B Jelf supported this proposal.

The Parish Council had not been furnished with any information from Mr Sean Halewood or Mrs Fay Price to come to any conclusions on the proposed mitigation options for Wallhill Lane. It was noted the traffic counts were being completed for the second week at this time. **Resolved** the Clerk would contact the CE Highways Officers to clarify the position of the Parish Council and to request a meeting.

19/2173W Bent Farm Quarry, Wallhill Lane, Brownlow, Congleton CW12 4HW –
extension to Bent farm quarry for the extraction of sand and progressive restoration.
 Resolved No Objection with conditions (avoidance of light pollution - Neighbourhood Plan Policy P9 refers).

The restoration plan for the existing quarry site was discussed at the Sibelco Liaison Meeting Tuesday 11th June attended by Cllr. J Carter & Cllr. B Jelf. Commencement was anticipated in 2022. There would be no access to the public.

The Chairman fed back the communication he had received.

• Weldhouse Farm

A representative from the Camping and Caravan club had attended site and made clear that the operation of selling / storing vehicles had to cease otherwise the certificate would be withdrawn. A CE planning enforcement officer had also attended site and made recommendations to the owner.

Cheshire Railings at Moreton Crossroads

Resolved Brook Brothers would be instructed to paint the Cheshire Railings Meeting with Mr C Hodgson- traffic issues around the Village Green

There had been a site visit with CH, ex Cllr R Bailey, the Chairman and the Clerk in February and there still had been no feedback from the officer. The Clerk requested support from the Ward Cllr.

Fence Lane and Wharf Lane

There had been concerns raised about the size of lorries travelling down Wharf Lane.

Resolved the Ward Cllr P Redstone would request a weight limit on Wharf Lane or the bridge from a safety position.

Hedge along Childs Lane

The Clerk had written to the owners in January and followed twice with phone calls. The hedge still had not been actioned.

Resolved the Clerk would contact highways to instruct enforcement.
