112/20 Minutes

Resolved the minutes from 12th August 2020 were accepted and signed as a true and accurate record.

113/20 Planning Applications

- 20/3221C Lavender Farm, Gorse Lane, Astbury CW12 3NR Alterations to form dormer and erection of detached garages.
 - **Resolved** No Objection
- 20/3521C 3 Derelict barns and land adjacent to Weld House Farm Barns, Peel Lane Astbury CW12 3NQ – the proposed development encompasses the conversion of three derelict barns to residential units. The scheme includes provision of pedestrian access routes and parking facilities.
 - **Resolved** Objection
- 20/3668C Corda Well Cottage, Mow Lane, Astbury CW12 3NJ Replacement of conservatory with side and rear extension with detached garage.
 Resolved No Objection

- i) <u>Stables and hard standing in a field on Fence Lane.</u>
 - The Clerk reported that the Enforcement Officer had visited the site and the landowner was now submitting a retrospective planning application for the hard standing that had been formed. The site was granted a change of use for the keeping of horses under application 31697/3 (although initially refused by the Authority the application was part allowed and part refused at appeal and granted change of use of land by the planning inspectorate).
- ii) Mill House Farm

The rural police had contacted the Clerk had explained that the dangerous bullock on site was being dealt with and although it seemed to be taking time the matter remains active.

- iii) Fly tipping on Sandy Lane PROW
 - This had been escalated and a site visit had taken place, but the sector was under pressure and the time factor was slowing the process down. It was being addressed.
- iv) To note no site visit from EA at Mill House Farm 1783927
- v) <u>To note no site visit from EA taken in reference to sewage in two registered</u> places ref 1807642
- vi) Caravans on site at Glebe farm

Cllr PC and the Clerk had visited the landowner and a report had been circulated on findings.

Resolved the report was accepted as a true record and the item would be revisited in three months to ensure the Camping and Caravan accredited exemption was in place.

114/20 Forgotten footpaths

The meeting had not yet taken place and this item was deferred until the next meeting. Cllr PCr showed some old maps which located some original footpaths he had identified.

115/20 Common Land

Cllr PC had met with Bartlett Tree experts on site to discuss options. He could complete a survey for £350.00 to £400.00. Cllr NP explained the PC had an obligation to maintain access and to improve the site and at this time it was overgrown and potentially dangerous if anybody entered it. The site needed clearing to gain access followed by management of the woodland and maintaining the biodiversity.

Resolved the site would be improved and to try and create a managed woodland.

Resolved Bartlett's Tree experts would be instructed to carry out a survey after a written quote had been submitted to the Clerk.

116/20 War Memorial

The Clerk had read the funding application in detail there seemed to be a great amount of background information to be drawn together before it could be submitted. It was agreed it would be analysed by the Clerk and Cllr PCr and the Chairman would assist.

117/20 Highways

- Wallhill Lane and BLH Lane
 - The works were in progress on BLH Lane. Wallhill Lane was due to commence after these works had been completed. One resident had submitted a concern, and this had been refereed to Mr S Halewood.
- Roundabouts on CLR

The Chairman and the Clerk had attended a meeting with Congleton Town Council to discuss the roundabouts on the CLR which was due to open in January 2021. One of the roundabouts on the A534 is in the Parish of Newbold Astbury and there was an offer to the PC to become involved in the setting out of this roundabout and then its future maintenance. The specific rules and guidance were shown to the members due to it being on a high-speed road the usual standards of Congleton would not be possible to achieve. The approximate costs were £600 set up costs and £700/£1,000 per annum maintenance costs. These costs would lie with the PC. CTC approached local businesses to sponsor their roundabouts and this in the main covered their maintenance costs. If not pursued by the PC, CTC would take over implementation and annual costs probably with Town/business sponsorship or they would be left as grass and cut twice a year by CE.

Resolved NACM PC agreed to take ownership of the setting up costs / future maintenance cost of the roundabouts in principle.

- Blocked gulley on A34 3388849 due for dig up still no actions taken.
- Gully outside The Chantry 3398834 still no actions taken.
- Bollard on pavement quote from JK Ashbrook's Ltd still outstanding.
- <u>A34 footpaths</u> the Chairman had spoken with Ms R Burgess CTC and this was being resolved.
- <u>Bench outside the Cemetery</u> following the tragic death of a teenager by the gates of the Cemetery on A34 in June the parents had requested a memorial bench to be placed on the grass verge at the family's cost.
 - Resolved this was acceptable with the Parish Council.
- <u>Village Green curb stones</u> no progress to date.
- Bulb planting in October

Resolved Cllr PCr would purchase some bulbs and planting would be agreed at the next meeting.
